1. Applications are invited in the prescribed format from the eligible candidates fulfilling the conditions given below for engagement of Act Apprentices for imparting training at Different Units over Northeast Frontier Railway under the Apprenticeship Act, 1961 and Apprenticeship Rules, 1992.

2. ELIGIBILITY CRITERIA:

(A) MINIMUM EDUCATIONAL QUALIFICATION

2.1 The candidate must have passed 10th class examination or its equivalent (under 10+2 examination system) with minimum 50% marks in aggregate from recognized Board and also should possess ITI in relevant trades approved by NCVT/SCVT.

(B) AGE LIMIT :

2.2 The candidates should have completed 15 years of age and should not have completed 24 years of age as on 18.09.2019.

2.3 Upper age limit is relaxable by 05 years in case of SC/ST candidates, 3 years in case of OBC candidates.

2.4 For persons with disability, upper age limit is relaxed by 10 years.

2.5 Upper age limit is relaxable by up to additional 10 years for ex-servicemen to the extent of service rendered in Defence Forces plus 03 years provided they have put in a minimum of 6 months service at a stretch, except Ex-servicemen who have already joined the Govt. service on Civil side after availing the servicemen status for the purpose of their engagement.

2.6 The candidates who want to avail the benefit of reservation of SC/ST, must produce his/her caste certificate on Central Government format issued by appropriate authority as per sample Annexure-C at the time of Document Verification. Similarly the candidates who want to avail the benefit of reservation of OBC, must annex OBC certificate and Non-Creamy Layer certificate issued on or after 01-01-2019 on Central Government format by appropriate authority as per sample Annexure-D.

2.7 The candidates who want to avail the benefit of reservation of Ex-servicemen and Armed Forces Personnel, must produce discharge certificate and in case of children of Ex-servicemen and children of Armed Forces Personnel, they must produce discharge certificate or Armed Forces serving certificate respectively (as the case may be) of his/her parents at the time of document verification.

3. EX-SERVICEMEN

3.1 An Ex-servicemen candidate selected under the reservation provided for them is to be placed in the appropriate category viz. UR/SC/ST/OBC to which he belongs. Reservations to Ex-servicemen, their children and children of Armed Force personnel will be engaged for Apprenticeship as per details mentioned below:

- Children of deceased/disabled Ex-servicemen including those killed/disabled during peace time.
- Children of Ex-servicemen
- Children of Serving Jawans
- Children of Serving Officer
- Ex-Servicemen

4. MODE OF SELECTION:

4.1 Selection will be on the basis of merit list prepared (trade wise) in respect of all the candidates who apply against the notification in respective Units. The merit list in each unit will be prepared on percentage of marks obtained in matriculation with minimum 50% (aggregate) marks. For the purpose of calculation of percentage of matriculation, marks obtained by the candidates in all subjects will be reckoned and not on the basis of marks of any subject or a group of subjects.

4.2 Shortlisted candidates, thus enlisted in respective units, will be called for document verification to the extent of 1.5 times of the notified vacancies.

4.3 In case of two candidates having the same marks, the candidates with older age shall be preferred. In case the dates of birth are also the same, then the candidate who passed matriculation examination earlier shall be considered first.

4.4 A final merit list will be prepared unit wise, trade wise and community wise, equal to the number of slots in the descending order of percentage of marks obtained by the candidate, as stated above.

4.5 Candidates finally enlisted would be subject to verification of original testimonials and being found fit in appropriate Medical examination as per Annexure E.

4.6 Willing candidates are advised to submit application well in advance before the closing date. Applications received after the last date will not be entertained under any circumstances.

5. CANDIDATES SHALL HAVE TO CHOOSE ONLY ONE UNIT.

NB : (i) Seats of PWD and Ex-Servicemen in the above tables are not separate, but included in the total number of seats as per provision.

(ii) When the prescribed number of persons belonging either to the Scheduled Castes or to the Scheduled Tribes are not available, the training slots so reserved for them may be filled by persons of either community, if available, and if the prescribed training slots cannot be filled even in the above given manner, then the training slots so lying unfilled may be filled by persons not belonging to the Scheduled Castes or the Scheduled Tribes. Similarly, the seats remaining unfilled by OBC candidates may be filled by unreserved category.

(iii) Railway administration reserves the right of imparting training of selected candidates in respective trades in any Departments of the concerned units.

7. STANDARDS OF FITNESS FOR THE PERSON WITH DISABILITY FOR ENGAGEMENT AS APPRENTICES

7.1 Only Loco motor or Cerebral palsy (OH) who suffers from not less than 40% of relevant disability and Hearing Handicapped (HH) having 60 decibels or more in the better ear in the conversational range of frequency are eligible to apply.

7.2 For Loco motor or Cerebral palsy (OH)

7.3 Low vision (VH) :

"Person with low vision" means a person with impairment of visual functioning even after treatment or standard refractive corrections but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

7.4 Person with Disability (PWD) who wants to avail the benefit of reservation must produce a disability certificate issued by a competent authority (i.e. Medical Board duly constituted by the Central or State Government).

7.5 Other than above mentioned Persons with Disabilities (PWD) candidates should not apply as PWD and they will not be eligible for such concessions/facilities.

7.6 Any other matter not mentioned above will be dealt as per the Apprenticeship Act, 1961 and Apprenticeship Rules, 1992.

8. HOW TO APPLY:-

8.1 One candidate can apply for only one unit and trade. The candidates applying for more than one unit will not be entertained.

8.2 The Application form & Call Letter as per prescribed format as stated in Annexure A & B must be submitted through registered post only in A-4 paper to the respective Unit duly filled in all respect by the candidate in his own hand writing with ball point pen to be addressed to the addresses of respective units as stated above in closed envelop enclosing the following :-

8.3 Self-addressed envelope of 11" x 5" with Postal Stamp of Rs. 5/- (Exemption for SC/ST Candidates).

8.4 A Crossed Postal Order in favour of Principal Financial Adviser, N.F. Railway, Maligaon payable to GPO/ Guwahati for Rs. 100/- (Exemption for SC/ST, PWD & women candidates) as a processing fee which is not refundable/transferable under any circumstances. The Postal Order purchased before the date of publication of this notice will not be valid.

OR

The fee can also be paid in the form of Account Payee demand draft drawn from any Nationalized Bank in favour of F.A. & C.A.O., N.F. Railway, and payable at SBI/Maligaon, Branch.

8.5 No fee is required for SC/ST/PH /Woman candidates.

- 8.6 2 recent Passport Size Photographs duly signed by the applicant, one of which should be pasted on Application Form in the space provided for and the another should be pasted on the 'CALL LETTER- CUM- ADMIT CARD' in the space provided.
- 8.7 The candidates should bring medical certificate at the time of document verification in the prescribed format as annexed in **Annexure E**.
9. The applications filled in all respects can also be **dropped in the Box** kept in the Welfare Section of the Office of the Divisional Railway Manager (Personnel) of the respective Divisions or Asstt./Senior **Personnel Officer of respective Workshops** on all the working days i.e. from Monday to Friday between 10.00 to 17.00 Hrs to be addressed to the specified address of the units as stated in para 5 above.
10. The application Form should be strictly as per format enclosed as Annexure-'A' & 'B' on good quality white paper of A4 size using one side only. The candidate must fill up his/her required information with ball pen on own handwriting in "English" only. The candidates should duly super scribe on the Cover enclosing applications and all other enclosures as "Application for engagement as Act-Apprentices & Designated trades applied forand..... Division/Workshop"
11. Self Attested Copies of all certificates viz. proof of date of birth, Educational /Technical Qualification, Caste Certificate, Ex.-Servicemen certificate, etc. should be submitted along with the application.
12. Copies of mark sheet & pass certificates of matriculation (10thstd), provisional certificate/National trade certificate (NTC) certificate issued by NCVT/SCVT in the case of ITI must be enclosed. Mere completion of course is not sufficient. **Candidates should have already passed the prescribed qualification on the date of issue of notification.**
13. In case of SC/ST/OBC candidates, a certificate from the appropriate authority, for their belonging to SC/ST/OBC categories should be submitted in the format prescribed by the Government of India (Annexure- C for SC/ST & Annexure-D for OBC)

The list of authorities empowered to issue SC/ST/OBC certificates are indicated below:-

15. If it is noticed by the Railway Administration that the applicant have furnished wrong information/fake certificates, the Railway administration reserves the right to discharge the candidate/ selected candidate at any stage without notice. FIR will be lodged for submitting false/ forged certificates & for furnishing wrong /false information or documents in support of their considerations.
16. The Railway administrations do not undertake any responsibility for sending reply to the candidates not selected or not called for. No correspondence in respect of the application submitted shall be entertained or replied by this office to any individual or organization. However, list of selected candidates will be uploaded in the Official website of N.F.Railway, which is www.nfr.indianrailways.gov.in.

Canvassing in any manner will be disqualification of the candidate.

17. The Railway administration will not be responsible for any postal delay/wrong delivery whatsoever at any stage of the Act Apprentice engagement process.

18 .IMPORTANT INSTRUCTIONS

18.1 The decision of the Railway administration in all matters relating to eligibility, acceptance or rejection of the applications and mode of selection shall be final.

18.2 Imparting Training in Railway will not confer any right to the candidates for their absorption in Railway after successful completion of training. In terms of para-10 of Schedule V of the Apprenticeship Rules,1991, notified on 15.07.92 by the Ministry of Labour, it shall not be obligatory on the part of the employer to offer any employment to the Apprentices on completion of period of his/her apprenticeship training in his / her establishment. Imparting training in Railway will not confer any right to the candidates for their absorption in Railway after completion of training.

18.3 No correspondences for absorption in Railway will be entertained.

18.4 Stipend will be paid as admissible as per extant instruction. Minimum stipend will be Rs.6960/-.

18.5 After selection for engagement, request of candidate to change the Division/unit will not be considered.

18.6 The Railway administration will not be responsible for any printing error.

18.7 No daily allowance / conveyance allowance or travelling allowance will be paid to the candidate who will be called for document verification.
